



OPENING MORE DOORS TO KIDS

Pediatric Care, Close to Home

After a hiatus due to the pandemic, Shriners Children's has resumed global travel. Recently, a team returned to Cyprus, an island country located in the eastern Mediterranean Sea. Here, Shriners Children's fills a critical need for pediatric specialty services in orthopedics, orthotic and prosthetic fabrication and more. While there, the team saw 143 patients from Cyprus and other countries including Egypt, Lebanon, Greece and Turkey.

Another team traveled to El Salvador to provide medical intervention to patients with scoliosis. The team also provided training for medical professionals there.


From injuries sustained on the playing field to those on the playground, our sports medicine programs specialize in the specific needs of children.

Genomics: Transforming Pediatric Care

Five years ago, the genomics institute launched at Shriners Children's. Its purpose: To improve outcomes for children with cerebral palsy, scoliosis and other neuromuscular conditions.


Genomics, the study of genes, makes it possible to predict, diagnose and treat diseases more precisely and personally than ever.

Each year, Shriners Children's collects a diverse set of genomes to help us determine if their unique characteristics are disease-specific or populationspecific. This research has the power to help Shriners Children's and other global health care organizations develop more targeted treatment plans for young patients.

The amazing genomics research your gifts are powering includes:

- · Examining scoliosis patients' DNA to identify genes contributing to the condition.
- Identifying the genetic causes of arthrogryposis (crooked joints) and finding ways to alleviate incapacitating symptoms, such as muscle contractures and severe pain.
- Understanding the role genes play in the development of cerebral palsy.

POPS Expands Possibilities for Patients

Shriners Children's Pediatric Orthotic and Prosthetic Services (POPS) designs, manufactures and fits orthotic and prosthetic devices for children of all ages.

As kids grow, their devices are customized and refitted to meet their needs and interests — allowing them to walk, run, jump and play.

In the past year, POPS introduced TLSO sensors and monitors for idiopathic scoliosis braces as part of the standard of care. This rollout provides real-time data on the hours



per day a thoracic lumbar-sacral orthosis is worn. Since outcomes are related to brace wear, this data will help inform individual patient treatment plans, helping improve effectiveness of this scoliosis treatment.

WAYS TO GIVE

There are many ways you can donate to help kids receive the pediatric specialty care they need and support the mission of Shriners Children's to change and improve the lives of children — wherever they may live.

Charitable Gift Annuities

(If permitted in your state)

An irrevocable contract between you and Shriners Hospitals for Children[®]. You transfer cash or other assets to us in exchange for guaranteed regular payments (to you as the donor) for life. The payment amount is determined by your age when the annuity is initially funded.

Donor-Advised Funds

A donor-advised fund (DAF), which is like a charitable savings account, gives you the flexibility to recommend how much and how often money is granted to Shriners Hospitals for Children and other qualified charities.

IRA Charitable Rollover

If you are age 70¹/₂ or older, you may make tax-free charitable gifts of up to \$100,000/year directly from your Individual Retirement Accounts.

Wills, Trusts and Bequests

A bequest is given by identifying Shriners Hospitals for Children as a beneficiary in your Will or Trust.

Gifts of Appreciated Assets

Shriners Children's gratefully accepts gifts in the form of stocks and appreciated securities. There are no capital gains taxes to be paid and, if you itemize deductions on your tax return, you may be able to claim the full appreciated amount as a charitable deduction up to 30% of your adjusted gross income.

Gifts of Real Estate

Donate any property type (land, homes, commercial), and net proceeds go directly to supporting our mission.

Give in Honor or Tribute

Pay tribute to a special person in your life with a donation made in their honor.
